- Student not in proper dress code will be sent home and their day will be counted as an absence.

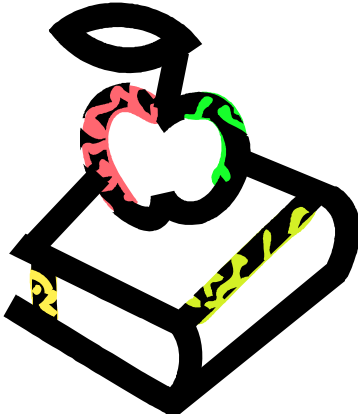
