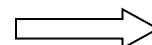

# DHS PARKING PERMIT CONTRACT

Please refer to page 90 of the 2019/2020 Student Handbook section titled, *“Vehicles and Parking”*. Leaving campus without permission will result in the parking sticker being confiscated.

- Parking decal must be visibly displayed on the front windshield of the vehicle (lower corner on the passenger side). Motorcycles will have the parking decal affixed on the vehicle so that it is easily seen.
- Students may only park in the following areas:
  - Stadium Parking Lot ( “A” Lot) located on Baker Drive- “Home Side”
  - Stadium Parking Lot ( “B” Lot) located on Baker Drive next to Baseball field and across from FFA Barn
- Park straight and between the lines
- If the parking sticker is confiscated, the parking fee is non-refundable
- Students may not go to the parking lot during school hours without written permission from an administrator
- The school reserves the right to tow and have impounded at the owner's expense any vehicle parked in violation of the regulations outlined on page 90 of the 2019-2020 student handbook section titled, “Vehicles and Parking”

I have read and understand the conditions of the parking permit contract and the student handbook section on “Vehicles and Parking”. I have also received a parking map detailing where student parking is located.

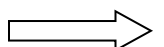
