##### **Bay Colony Elementary will:**

- **Teachers will teach reading using the balanced literacy approach to reading instruction to meet student's individual phonics and help each student increase his/her individual reading level.** Grade level teachers will plan as a team for all curricular content areas. Instructional coaches will be part of the team planning. Instructional practices will be adjusted to meet individual student needs. Bilingual students will receive appropriate levels of language support to prepare them to be adequately prepared to become biliterate.
- **Hold parent-teacher conferences each fall in person or online during which this compact will be discussed as it relates to the individual child's achievement.**
- **Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows: Progress reports and report cards will be available on skyward. Parents can access student grades and information at any time. Teachers will send home student graded work and campus/class specific information weekly and /or as necessary.
- **Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows: Teachers are available four days a week during scheduled conferences periods. The school counselor is available daily and campus administrators are available as needed.
- **Provide parents opportunities to volunteer and participate in their child's class and to observe classroom activities.** Parents are encouraged to join the PTO and volunteer based on the classroom needs for individual teachers.
